**Restatement of Reserved Rights:**

Without limiting any of the provisions of the contract or the contract conditions, it is specifically understood and agreed by the exhibitor that the Management of the Beaucore Enterprises, Inc. reserves the rights enumerated below without incurring any liability to the exhibitor or releasing the exhibitor from any of its covenants and obligation under the contract.

- 1.To change the hours of the Show.
- 2.To allocate exhibit space, subject to the standards set forth in the contract.
- 3.To change, at any time prior to the scheduled opening date of the Show, the dates of the Show (provided such changes shall not result in a reduction of the number of days of the Show); the floor plan, or the location of the Show.
- 4.To determine the suitability of all exhibits and demonstrations.

It is further understood and agreed that the Management of the Show shall have each and all of the other rights and reservations contained in this contract.

**Insurance & Liability:**

Fire and theft insurance covering the Exhibitor’s property, if desired, must be taken out by the exhibitor at his own expense. Beaucore Enterprises Inc. will not be liable for damage done in your booth such as malpractice, or any loss of exhibitor’s property through fire, theft, accident or any other cause. Exhibitors are expected to maintain personnel in their exhibit booth at all times during the show hours. All merchandise and portable exhibits are to be removed promptly post exhibit hours.

**Booth & Product Display:**

No exhibitor can display in his booth any products, equipment or merchandise of any kind that was not included in booth contract description. Failure to abide will result in immediate removal from exhibit hall with all monies forfeited to show management. Refunds will not be made and Beaucore Enterprises, Inc. may, without incurring any liability of any kind whatsoever, require an Exhibitor who violates any of the provisions of this contract or of its show. Upon a breach of the contract by the Exhibitor, the management of the Show shall have the right to retain all fees and deposits therefore paid as liquidated and not as a penalty.

Designated set-up/move in time will be determined by Beaucore Enterprises, Inc. There will be no additional scheduled times/dates for set-up of sponsorship exhibiting material other that pre-designated time and date. In the event sponsor is unable to have items available for pre-event set-up then Beaucore Enterprises/Beaucore Helps will not be held liable and no reimbursement of sponsorship/ fees will be granted. Breakdown must occur after pre-scheduled event end time.

**Acts of God, Strikes, Fire, Etc.**

In the event that any outside cause, such as war, fire, strike or other emergency, prevents Jax Community & Family Awareness Expo from being held, the Show Management may retain such part of the Exhibitor’s rental as shall be required to recompense management for expenses incurred up to the time such contingency shall have occurred
